Attached is an application for State Representative. Those students who will be sophomore, junior or senior during the 2010-2011 school year are eligible to apply. Please read the following requirements and make sure you are able to commit to everything. Complete the application and return it to the CHSAA office by July 1, 2010.

All newly elected State Representatives are required to attend a mandatory breakfast meeting. The site, date and time will not be available until after our Summer Camp on July 26-29,2010., where the following responsibilities will be reviewed:

- Must attend the State Conference in October and be present for the ENTIRE training and conference. The information for this conference will not be available until after our Summer Camp on July 26-29,2010.
- Each State Representative will be responsible for conducting a leadership workshop for about 30 students. You must have the workshop and all materials prepared before the conference. Topics should be approved by Ruthie Palmer.
- State Representatives will be trained in the curriculum, but you alone will be responsible for leading the boundary breakers, silly songs and activities. An adult advisor will be present but YOU are the leader and the adult is your "helper."
- During the 2010-2011 school year, you will be in contact with the State President. She/he will need your help in conducting the state community service, as well as providing communication between the state level and the schools in your area.
- Finally, at the end of the training day you will vote on the next State President. This person must currently be a junior and will be President Elect for the 2011-2012 school year. They will officially take office on June 1, 2011. The President Elect is required to attend the National Student Council Conference in June.
